

Saint Paul Children's Collaborative APPROVED Minutes Meeting of the Board of Directors Wednesday, August 12, 2015 8:15-10:00 @ CAP/RW

Meeting called to order by O'Connell at 8:20 am.

I. Call to Order and Children's Fire

Eastwood lit the Children's Fire with words about how we get busy thinking about adults, and trying to get them to do their work differently, often missing actually interacting with youth. The challenges of doing that work while keeping youth top of mind. There are ways that makes sense, since adults cause most of the problems faced by our youth.

II. Consent Agenda

Motion to approve the Minutes from the June 10, 2015 Board Meeting and accept the information contained in the July update from Advance Consulting. Motion approved.

There was discussion about whether SPPS could help Head Start assign MMARS numbers to Head Start students. Stacey Gray-Akyea from SPPS thought that would not be a problem.

There was also discussion with the Board about the recent allegations about SPCC grantee Breaking Free. At this point, we believe they are spending our grant funds in accordance with the grant agreement and staff will keep the Board apprised as more information becomes available.

III. Data Discussion

Stacey Gray-Akyea and Lisa Thao from SPPS presented student outcome data, disaggregating the "Asian" population, from the 2013-14 school year. In 2014, SPPS formed an Asian Affinity Group for staff, which eventually made the request for disaggregation of Asian data. They presented the demographics Asian students, school enrollment patterns, school climate/interactions, achievement patterns and college/career readiness. It is important to note that there are actually three indicators for "Asian" students: race/ethnicity; home language; and ELL services receipt. Staff documented questions to send to Stacey for response. The revised PPT and response will be distributed to the board.
